We offer researchers two solutions for accessing official copies of recorded documents at our counties.

- #1 Document Purchase Plan
- #2 Research Plan

This document discusses our Research Plan.

What does is this Plan provide?

The Research Plan allows you to search all records from a single county for a flat monthly fee. There are no per page costs.

tcrWebTools: Search Tool

All our plans include use of our advanced search software tool, tcrWebTools.

tcrWebTools is a desktop software search tool that provides advanced search and document access capabilities. It provides the researcher with the same power and efficiency as if you were searching records at the Recorder's Office.

Installation Notes	tcrWebTools is a Microsoft Windows desktop application. It is not a web application. It is installed on the researcher's computer along with the Microsoft .Net Framework.	
Apple Mac Users	tcrWebTools will not install or run natively on a Mac. It is our understanding that Apple has a plug-in available that will allow a Mac to run Windows software. This plug-in is required to install and run tcrWebTools. We are unable to support this effort and encourage Mac users to contact Apple for assistance.	

How does the Research Plan work?

When you open a document om tcrWebTools the image file is automatically downloaded to your local computer. The image is then displayed to view, print or access at any time.

How is service provided?

Service is provided by location.

You can choose to have service provided to your staff at a single location (Standard Service) or at all your office locations (Enterprise Service).

For example, you desire staff to have research capability at your Denver office, this is Standard Service.

Let's say you have multiple office locations, for example in Denver, Grand Junction and Durango. You can setup a single account to provide service to all three office locations. This is what we call Enterprise Service.

What does it cost?

There are two <u>monthly</u> costs associated with each plan, a service fee and a County data fee. We collect the data fee on behalf of the County, the service fee is for our services.
